Basic Operating Finances Are Now Stable But Physical Plant Needs Are Pressing

Considerable progress has been made during the past year. We have cleaned up our act and restored financial stability to both the Actives and Alumni Corp. operations. The result of perseverance by the Actives to austerity budgeting with emphasis on recruiting good people and participation by many of our Alums to support our goals and efforts financially. MANY THANKS TO ALL WHO PARTICIPATED IN THE TURNAROUND!!

The Actives have a reasonable budget in place with all accounts current for the first time in more than several years. And, they are able to pay the full amount of their rent due to the Alumni Corp., also for the first time in more than several years. The benefit of an almost full house and cleaning up past debt.

The Alumni Corp. finances are now stable from an operating viewpoint but still heavily dependent upon dues payment and contributions to operate our business as the landlords of 351 E. Fairmount Ave.

Significant events: the \$372,311 mortgage balance was refinanced in January from 9.75% fixed to 7.00% fixed, saving \$7,498 per year. Alumni dues and contributions are now accounted for as separate categories. Everyone will hear more about this when annual dues statements are mailed in late October or early November. Provisions to reestablish reserve accounts, which were gutted to get through the past several years, have been made.

Our basic annual operations picture is as follows:

* Note: Surprises last year were: replace Hot Water Heater (\$3,800) and Replace Stove (\$1,200). Surprises this year to date are: lightening ruined central alarm panel (\$1,200); the untimely death of an undergraduate brother (\$1,158 for chartered bus service)

Our property at 351 E. Fairmount Ave. is now 75 years old and needs considerable restoration and facilities upgrade attention. A list of pressing projects prepared last Spring totaled about \$80,000. \$29,294 has been raised through September 16, 2002. Summer projects completed totaled \$17,700. Significant items were: first floor floors refinished; new carpet; chapter room floor replaced; exterior paving; ethernet system installed; and, maintenance items brought up to code. Exterior work now currently underway totals about \$15,000.

Major unsubscribed items are: replace corroded 75 year old main water supply (\$11,500 to \$12,000); major repair and replacement of 2nd and 3rd floor showers to prevent potential damage to ceilings (\$7,000). Anyone able and interested in underwriting either of these requirements?

Another goal on the agenda, for the point where our finances continue to improve to a better level, is to be able to make prepayments on the mortgage to save on interest expense.
