Good financial practices are in place, and the undergraduate chapter operated within budget for the period ending December 31, 2002, and under budget for the past three six-month periods.

The net result is that the finances of the undergraduate chapter are stable. All bills are paid on time.

meet our obligations to maintain, repair and make necessary improvements to the chapter house; i.e., dues, contributions and patio-brick purchases. Virtually every dollar received from these efforts goes back into the chapter house, which had been neglected for quite a few years prior to 2001.



The Chapter Room has been renovated with new lighting and ventilation and removal of the old cooler system. This should alleviate any dampness on the ground floor.

Maintenance, repair and improvements completed this summer totaled about \$22,700. This results in a total of \$99,251 that has been put into our physical plant since 2001 without incurring additional debt. A huge 'thank you' goes out to all participating alumni who made this possible.

Our current list of physical plant matters that need to be addressed approaches \$25,000

at this time. Our alumni base is large enough to support our obligations for necessary maintenance, repairs and improvements. We do, however, need to show improvement in the number of brothers participating and in consistency of participation.

Here are a few facts to support this observation:

Our mailing list of living alumni averages 900. There are always a few additions and deletions on an annual basis. From September



A crew employed a cherry picker to paint the exterior. In total, \$25,000 went to improvements over the summer.

1, 2001, to June 9, 2004, 319 brothers — or 35.4 percent — have paid annual dues. About 50 percent of the brothers paying their annual dues also either made an additional contribution or purchased a brick, or both.

Here is the breakdown of those paying dues, by academic year

running from September 1 through August 31:

Academic year 2002 — Dues paid by 115 brothers, or 12.8 percent. Note: This does not include the 60 to 65 brothers who chipped in heavily during the 2000-01 bail-out situation.

Academic year 2003 — Dues paid by 227 brothers, or 25.2 percent.

Academic year 2004 (through August 4) — Dues paid by 221 brothers, or 24.6 percent.



Main level floors received another coat of Polyurethane, the third in three years, which should ensure that the hard wood is adequately protected.

Life memberships — 12, with 15 brothers making installment payments.

Commemorative bricks purchased — 151

One last point: We have been handling our maintenance, repair and improvements obligations on a hand-to-mouth basis. We really need to begin developing a reserve account to handle major needs such as the roof or boiler replacement. We can get there with increased participation and consistency of participation.
